Whereas, no activity having bearing on environment can be taken in hand without prior consent of the Pollution Control Board, warranted under Section 25/26 and Section 21 of the Water (Prevention and Control of Pollution) Act 1974 and Air (Prevention and Control of Pollution) Act, 1981 respectively.

Whereas, **M/s Bombay Shoe Company, Krishna Nagar, Jammu** has been and put it in operation in violation of above stated laws that too bereft of adequate pollution control devices/ measures in residential area.

Whereas, pressing complaints against the operation of the unit from the local residents have been received for causing pollution in the area which stand verified.

Whereas, the unit holder was accordingly served with repeated notices, particularly notice dated **07-03-2018**, calling upon him there under to show reasons as to why legal action including closure of his unit be not taken.


Whereas, the unit holder has failed to show any response to the notices, besides failing to take measures to meet the requirements of laws governing environmental protection.


Whereas, the unit in question cannot be allowed to run un-authorizedly with above status and to the detriment of human health and environment.

Now therefore, in exercise of powers vested in the J & K State Pollution Control Board under Section 31 (A) of the Air (Prevention and Control of Pollution) Act, 1981, immediate closure of **M/s Bombay Shoe Company, Krishna Nagar, Jammu**, is hereby ordered and in this behalf the:-

- i). Deputy Commissioner/ District Magistrate, **Jammu** is directed to close **M/s Bombay Shoe Company, Krishna Nagar, Jammu**, immediately.
- ii). Chief Engg Electric Maintenance (PDD) **Canal Road, Jammu** is directed to snap the electric supply to the above said unit immediately.
- iii). Director Industries & Commerce, **Jammu** for deregistering the above said unit.
- iv). Prop. **M/s Bombay Shoe Company, Krishna Nagar, Jammu**, is directed to cease the operation of the unit forthwith.
