ORDER No. : 134 SPCB of 2019

Whereas, Consent to Operate (Renewal) issued by the J&K State Pollution Control Board to M/s Mohammad Jaffer Mattoo Stone Crusher Rakshalina, Lasjan Budgam has expired in the year, 2018 and thereafter unit holder has failed to obtain periodical renewals as warranted under Section 25/26 and Section 21 of the Water (Prevention and Control of Pollution) Act 1974 and Air (Prevention and Control of Pollution) Act, 1981 respectively..

Whereas, on the basis of pollution potential, stone crusher is classified in Orange category, for the purposes obtaining of up to date consent from the Board, which the unit holder has failed to obtain, thus continues illegal and unauthorized operation of the unit..

Whereas, unit in question is also operational bereft of requisite pollution control devices, causing pollution beyond permissible norms, endangering human health and environment.

Whereas, after serving several individual notices upon the above said unit holder, a public notice through local Newspaper namely "Daily Aftab" dated 09-04-2018, was issued calling upon there under the defaulting unit holders including M/s Mohammad Jaffer Mattoo stone crusher Rakshalina, Lasjan Budgam to show reasons as to why legal action including closure of his unit be not taken, to which unit holder failed to respond.

Now therefore in exercise of powers vested in the J & K State Pollution Control Board under Section 31 (A) of the Air (Prevention and Control of Pollution) Act, 1981, immediate closure of M/s Mohammad Jaffer Mattoo stone crusher Rakshalina, Lasjan Budgam is hereby ordered and in this behalf the:-

- i). Deputy Commissioner/ District Magistrate, Budgam is directed to get the M/s Mohammad Jaffer Mattoo stone crusher Rakshalina, Lasjan Budgam, closed immediately.
- ii). Chief Engineer, Electric & Maintenance (PDD) Kashmir, is directed to snap the electric supply to the above said unit.
- iii). Director Industries & Commerce, Kashmir for deregistering the above said unit.
- iv). Prop. M/s Mohammad Jaffer Mattoo stone crusher Rakshalina, Lasjan Budgam is directed to cease the operation of the unit forthwith.
