Whereas, no industrial unit can be installed or put in operation, without prior consent of the Pollution Control Board, warranted under Section 25/26 and Section 21 of the **Water (Prevention and Control of Pollution) Act 1974** and **Air (Prevention and Control of Pollution) Act, 1981** respectively.

Whereas, a Leather Tanning unit run by **Mr. Asif Bashir Ganie , S/o Bashir Ahmad Ganie R/o Kani-Mazar Nawakadal, Srinagar** under the name and Style of **M/s Golden Tanners at IGC Lassipora Pulwama** is currently operational in violation of above stated laws that too without adequate pollution control devices/pollution control measures.

Whereas, the unit **falls in Red** category as the activity carried out in the unit is highly polluting one, deficient in PCDs/PCMs and resulting pollution load beyond permissible limits.

Whereas, notices were accordingly served upon the unit holder, latest in the series on **27-02-2020**, calling upon him there under to show reasons as to why legal action including closure of his unit be not taken, to which unit holder failed to respond.

Whereas, unit holder has failed to show any response to these notices besides failing to take measures to meet the requirements of laws governing environmental protection.


Whereas, field staff of the Board conducted inspection` of unit on **18-03-2020** and it has been found that Effluent Treatment Plant (ETP) installed but was found non functional at the time of inspection and it has also been reported by the field staff that the Effluents Treatment Plant(ETP) is deficit in actual requirement.

Whereas, the unit in question cannot be allowed to run un authorizedly with above status and to the detriment of human health and Environment.

Now, therefore, in exercise of powers vested in the J & K Pollution Control Board under **Section 33 (A) of Water (Prevention and Control of Pollution) Act, 1974** and **Section 31 (A) of the Air (Prevention and Control of Pollution) Act, 1981**, immediate closure of the Leather Tanning unit under the name and style of **M/s Golden Tanners at IGC Lassipora Pulwama of Mr. Asif Bashir Ganie , S/o Bashir Ahmad Ganie R/o Kani-Mazar Nawakadal, Srinagar** is hereby ordered and in this behalf the:-

- i). Deputy Commissioner/ District Magistrate, **Pulwama** is directed to get Leather Tanning unit under the name and style of **M/s Golden Tanners at IGC Lassipora Pulwama of Mr. Asif Bashir Ganie , S/o Bashir Ahmad Ganie R/o Kani-Mazar Nawakadal, Srinagar**, closed immediately.
- ii). Chief Engineer, Electric & Maintenance (PDD) **Kashmir** is directed to snap the electric supply to the above said unit immediately.
- iii). **Mr. Asif Bashir Ganie , S/o Bashir Ahmad Ganie R/o Kani-Mazar Nawakadal, Srinagar** Prop. Leather Tanning unit under the name and style of **M/s Golden Tanners at IGC Lassipora Pulwama** of is directed to cease the operation of the unit forthwith.
