
Whereas, closure of M/s **Hotel Rivera, Brain Nishat, Srinagar** was ordered by the Board vide Order No. **172 PCB of 2020** dt. **17-03-2020** for being operational without consent of the JK Pollution Control Committee and bereft of facility of pollution control devices/measures, especially the facility of STP.


Whereas, on carrying out fresh inspection on **21-10-2021**, the Divisional Officer, Pollution Control Committee, Srinagar has reported vide No. **PCC/DO/Sgr/21/139** dt. **05-11-2021** that the hotel is already connected with **STP Laam (LCMA)** and has adopted / installed adequate Pollution Control Devices/Pollution Control Measures.

Whereas, Regional Pollution Control Committee, Kashmir vide letter No. **PCC/ROK/LS/21/295** dt. **18-11-2021** confirmed the report of the Divisional Officer, Pollution Control Committee, Srinagar and has accordingly recommended the withdrawal of closure order.

Now, therefore, closure order No. **172 PCB of 2020** dt. **17-03-2020** issued against **M/s Hotel Rivera, Brain Nishat, Srinagar** is hereby withdrawn forthwith, subject to the condition that the hotel will not be put into commercial operation without obtaining mandatory consent of the JK Pollution Control Committee.
