
Whereas, M/s Arise Hyundai Pvt. Ltd Baripora Handwara Kupwara, with facility of car washing has been setup and put in operation in violation of the above stated laws, that too without having treatment plant for effluent in place and functional in the unit.


Whereas, the unit holder was accordingly served with repeated notices, particularly notice dated 11/03/19, calling upon him there-under to show reasons as to why legal action including closure of his show room be not taken for violation of law.

Whereas, the unit in question, cannot be allowed to run un-authorizedly with above status and to the detriment of human health and environment.

Now therefore, in exercise of powers vested in the J & K State Pollution Control Board under Section 31 (A) of the Air (Prevention and Control of Pollution) Act, 1981, immediate closure of show room of M/s Arise Hyundai Pvt. Ltd Baripora Handwara Kupwara, Kashmir, is hereby ordered and in this behalf the:-

- i). Deputy Commissioner/ District Magistrate, Kupwara is directed to get the Workshop and Service Station of M/s Arise Hyundai Pvt. Ltd Baripora Handwara Kupwara, Kashmir therein closed immediately.
- ii). Chief Engineer, Electric & Maintenance (PDD) Kashmir is directed to snap the electric supply to the M/s Arise Hyundai Pvt. Ltd Baripora Handwara Kupwara, Kashmir..
- iii). Chief Engineer, PHE, Kashmir to snap water supply to M/s Arise Hyundai Pvt. Ltd Baripora Handwara Kupwara, Kashmir
- iv). Prop. M/s Arise Hyundai Pvt. Ltd Baripora Handwara Kupwara, Kashmir is directed to cease the operation of the showroom forthwith.
