Whereas, no activity, causing water/air pollution can be taken in hand without consent of the Board as envisaged under Section 25/26 and Section 21 of the Water (Prevention & Control of Pollution) Act, 1974 and Air (Prevention & Control of Pollution) Act, 1981 respectively.

Whereas, last consent granted to the M/s Valley Dressed Chicken, Wahabpora-Budgam has expired and the unit holder has failed to obtain periodical renewals of the consent from the Pollution Control Board as such the unit is presently in illegal and unauthorized operation in flagrant violation of the above stated laws that too without adequate pollution control devices/pollution control measures.

Whereas, the unit holder was accordingly served with repeated notices, particularly notice dated 04-12-2018, calling upon him there under to show reasons as to why legal action including closure of his unit be not taken.

Whereas, the unit holder has failed to show any tenable response to the notice, besides failing to take measures to meet the requirements of laws governing environmental protection

Whereas, the unit in question cannot be allowed to run un-authorizedly with above status and to the detriment of human health and environment.

Now therefore in exercise of powers vested in the J & K State Pollution Control Board under Section 33 (A) and Section 31 (A) of the Water (Prevention & Control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981 respectively, immediate closure of M/s Valley Dressed Chicken, Wahabpora -Budgam is hereby ordered and in this behalf the:-

- i). Deputy Commissioner/ District Magistrate, Budgam is directed to close M/ Valley Dressed Chicken, Wahabpora -Budgam, immediately.
- ii). Chief Engineer, Electric & Maintenance (PDD), Kashmir is directed to snap the electric supply to the above said unit, immediately.
- iii). Chief Engineer PHE, Kashmir is directed to snap water supply to the above said unit, immediately.
- iv). Director Industries & Commerce, Kashmir is directed to deregister the unit.
- v). Prop. M/s Valley Dressed Chicken, Wahabpora -Budgam is directed to cease the operation of the unit forthwith.
