



GRANT OF AUTHORIZATION (Fresh for substantial expansion) TO OCCUPIER OR OPERATOR FOR HANDLING HAZARDOUS WASTES

1. Number of authorization and date of issue 05 of 2016, dated 2-4-2016
2. M/s **Dhanuka Agritech Ltd.** is hereby granted an authorization for storage of hazardous waste on the premises situated at **SICOP Industrial Estate Battal Ballian Udhampur.**
3. The authorization is granted for storage of hazardous waste generated from the process of **Pesticides formulation (Qty. 5900 MT/annum) for substantial expansion.**
4. The authorization shall be in force for a period of up to **March 2017.**
5. The authorization is subject to the conditions stated below and such other conditions as may be specified in the rules for the time being in force under the Environment (Protection) Act, 1986.

Terms and Condition of Authorization:

1. The authorization shall comply with the provisions of the Environment (Protection) Act, 1986, and the rules made there under.
2. The authorization or its renewal shall be produced for inspection at the request of an Officer authorized by the State Pollution Control Board.
3. Any unauthorized change in personnel equipment as working conditions as mentioned in the application by the person authorized shall constitute a breach of the authorization.
4. An application for the renewal of an authorization shall be made in form I before its expiry.

5. The applicant should maintain records of hazardous waste generated as per "Form-3" and produce the same at the time of inspection.
6. The applicant should submit "Form-4" for filling returns as per Hazardous Waste (Management, Handling & Transboundary) rules 2008, by 30th June, every year for the preceding period April to March.
7. Hazardous Chemicals be stored as per the Manufacture, Storage and Import of Hazardous Chemicals Rules, 1989.
8. The applicant shall return the empty barrels / containers to the supplier / authorized recycler only.
9. The applicant shall dispose of used oil to registered / authorized recycler only.
10. The applicant shall make sure that the hazardous waste are packaged and labeled based on the composition in a manner suitable for safe handling and storage as per guidelines under rules.
11. The applicant shall properly maintain display board regarding hazardous waste.
12. The applicant shall properly label the hazardous waste and maintain the hazardous waste room and submit the photographic proof of the same within a period of three months.
13. The applicant shall maintain the manifests regarding transportation of hazardous waste on form 3 and 4 shall maintain. The copies of form 3 and 4 shall be submitted by the unit holder to the State Pollution Control Board at the time of renewal.
14. The applicant shall also submit NOC from the concerned State Pollution Control Board in case the waste is to be transported to another State.
