GRANT OF AUTHORIZATION (RENEWAL) TO OCCUPIER OR OPERATOR FOR HANDLING HAZARDOUS WASTES

1. Number of authorization and date of issue 32 of dt 27.4. wh

- M/s Metal and Pigments is hereby granted an authorization to operate a facility for storage of hazardous waste on the premises situated at <u>Logate Morh</u>, <u>Kathua</u>.
- 3. The authorization granted is to operate a facility for storage of hazardous waste generated from the process of manufacturing of Cadmium metal and Cadmium sulphide, Zinc metal and Zinc sulphate and Ferrous sulphate only (12600 MTA).
- 4. The authorization shall be in force for a period up to March 2019.
- 5. The authorization is subject to the conditions stated below and such other conditions as may be specified in the rules for the time being in force under the Environment (Protection) Act, 1986.

Terms and Condition of Authorization

- The authorization shall comply with the provisions of the Environment (Protection) Act,
 1986, and the rules made there under.
- 2. The authorization or its renewal shall be produced for inspection at the request of an officer authorized by the State Pollution Control Board.
- 3. The person authorized shall not rent, lend, sell, transfer or otherwise transport the hazardous waste without obtaining prior permission of the Board.

- 4. An application for the renewal of an authorization shall be made in "Form-1" before its expiry.
- 5. The applicant should maintain records of hazardous waste generated at the facility, as per "Form-3".
- The applicant should submit "Form-4" for filing returns as per Hazardous Wastes Rules, by 30th June, every year for the preceding period April to March.
- 7. The applicant shall submit "Form-6" for filing returns as per Hazardous Wastes Rules, by 30th June, 2016, for the preceding period April to March.
- 8. The applicant shall permanently mark the display board and submit the photographic proof within one month.
- The applicant shall make sure that the hazardous wastes are packaged and labeled based on the composition in a manner suitable for safe handling & storage as per the guidelines under rules.
- 10. The applicant should apply 45 days in advance for renewal of authorization before expiry of the authorization.
