- Under Section 21 of the Air (Prevention & Control of Pollution) Act, 1981, as amended

**CONSENT is granted to M/s International Cattle Feed  
Village Jindlerhar R S Pura Jammu.**

Located in the area declared under the provisions of the Water Act / Air Act, subject to the provisions of the Act and the Orders that may be made further and subject to the following terms and conditions:-

1. The Consent to **Operate(Renewal)** is granted for a period up to **March 2018**.
2. The consent granted by the Board is restricted to Prevention and Control of Pollution only and shall not be treated as substitute of permission required under other laws of the land.
3. Category of the unit as per UCM Guidelines: **Orange**.
4. The Consent is valid for the manufacture of the following products / by-products with capital investment (Land, plant and machinery) of **Rs. 34.57 lacs**
5. The unit is registered with DIC vide registration No:07/04/09896 dt: 23-6-2008.

6. *The emissions or discharge of environmental pollutants from the unit / establishment shall not exceed the relevant parameters and standards for the said industry, operation or process specified under respective schedules of the Environment (Protection) Rules, 1986 as amended from time to time.*

7. Conditions under Water Act :

- (i) The daily quantity of trade effluent from the unit shall not exceed the permissible quantity approved.
- (ii) The daily quantity of sewage effluent from the unit shall not exceed the permissible quantity approved.
- (iii) The daily quantity of water consumption shall not exceed 0.5 KLD

Treatment : The applicant has to operate and maintain a comprehensive treatment system consisting of Primary / Secondary and / or Tertiary treatment as is warranted with reference to influent quality and operate and maintain the same continuously so as to achieve the quality of the treated effluent to the following standards before disposal.

(1) pH	Between	6.5 and 8.5
(2) Suspended Solids	Not to exceed	100mg/L.
(3) BOD, 3 days, 27°C	Not to exceed	30mg/L
(4) C.O.D.	Not to exceed	250mg/L.
(5) Oil & Grease	Not to exceed	10mg/L.

**(iv) Trade Effluent Disposal Outlet Conditions :**

The unit holder must ensure the safe disposal of effluent by adopting the Pollution control measures and installation of required pollution control devices as per the Water (Prevention & Control of Pollution) Act, 1974 and amendments made thereafter.

**(v) Sewage Treatment** – The applicant has to install a comprehensive treatment system as is warranted with reference to effluent quality and operate and maintain the same continuously so as to achieve the quality of treated effluent to the following standards before disposal :-

pH	Between	5.5 and 9.0
Suspended Solids	Not to exceed	100mg/l.
B.O.D., 3 days, 27°C	Not to exceed	30 mg/l.

**(vi) Sewage Disposal Outlet Conditions :**

All the domestic waste water shall be collected in the Septic tank and soakage pit

**(vii) Non-hazardous solid waste (TPD./TPM):** The non-hazardous solid waste has to be handled and disposed as per the guidelines of Municipal Solid Waste Rules, 2000.
