GRANT OF AUTHORIZATION (RENEWAL) TO OCCUPIER OR OPERATOR FOR HANDLING HAZARDOUS WASTES

1. Number of authorization and date of issue 15 of 2016 dt 9.4.2016
2. M/s B. R. Agrotech Ltd. is hereby granted an authorization (renewal) to operate a facility for storage of hazardous waste on the premises situated at SIDCO Industrial Complex, Kathua.
3. The authorization granted is to operate a facility for storage of hazardous waste generated from the manufacturing process of Pesticide Formulation (6320 MTA).
4. The authorization (renewal) shall be in force for a period up to **March 2017.**
5. The authorization (renewal) is subject to the conditions stated below and such other conditions as may be specified in the rules for the time being in force under the Environment (Protection) Act, 1986.

Terms and Condition of Authorization

1. The authorization shall comply with the provisions of the Environment (Protection) Act, 1986, and the rules made there under.
2. The authorization or its renewal shall be produced for inspection at the request of an officer authorized by the State Pollution Control Board.
3. The person authorized shall not rent, lend, sell, transfer or otherwise transport the hazardous waste without obtaining prior permission of the State Pollution Control Board.

4. An application for the renewal of an authorization shall be made in "Form-1" before its expiry.
5. The applicant shall maintain records of hazardous waste generated at the facility, as per "Form-3".
6. The applicant should submit "Form-4" for filing returns as per Hazardous Waste (Management, Handling and Transboundary Movement) Rules 2008, by 30th June, every year for the preceding period April to March.
7. The applicant shall make sure that the hazardous wastes are packaged and labeled based on the composition in a manner suitable for safe handling & storage as per the guidelines under rules.
8. Hazardous Chemicals be stored as per the Manufacture, Storage and Import of Hazardous Chemical Rules, 1989.
9. The applicant shall submit renewed Public Liability Insurance (PLI), along with a copy of Form III of Environment Relief Fund (ERF) Scheme under the Public Liability Insurance Act, 1991, as the same is expiring on 12/06/2016.
10. **The applicant should submit Safety Audit Report (External) and renewed Explosive license with in a period of one month.**
11. The applicant should return the empty barrels /containers to the supplier only.
12. The applicant shall conduct Mock Drills at least twice a year and submit the details of the same to the Board along with photographic proof.
13. The applicant should apply 45 days in advance for renewal of authorization before expiry of the authorization
