**GRANT OF AUTHORIZATION (RENEWAL) TO OCCUPIER OR OPERATOR FOR  
HANDLING HAZARDOUS WASTES**

1. Number of authorization and date of issue 28 of 2016 dt 20.4.016
2. **M/s Punjab Steel Rolling Mills** is hereby granted an authorization (renewal) for storage of hazardous waste on the premises situated at **Plot No. 59, Phase II, Industrial area Gangyal.**
3. The authorization granted is for storage of hazardous waste generated during the manufacturing process of ***Tor steel, Flats, Round, Square, Angle and Sections (4161.12 MTA).***
4. The authorization (renewal) shall be in force for a period **up to March 2017.**
5. The authorization is subject to the conditions stated below and such other conditions as may be specified in the rules for the time being in force under the Environment (Protection) Act, 1986.

**Terms and Condition of Authorization**

1. The authorization shall comply with the provisions of the Environment (Protection) Act, 1986, and the rules made there under.
2. The authorization or its renewal shall be produced for inspection at the request of an officer authorized by the State Pollution Control Board.

3. An application for the renewal of an authorization shall be made in "Form-1" before its expiry.
4. The applicant should maintain records of hazardous waste generated at the facility, as per "Form-3".
5. The applicant should submit "Form-4" for filing returns as per Hazardous Wastes (Management, Handling and Transboundary Movement) Rules 2008, by 30<sup>th</sup> June, every year for the preceding period April to March.
6. **The applicant shall make sure that the hazardous wastes are packaged and labeled based on the composition in a manner suitable for safe handling & storage as per the guidelines under rules and submit the photographic proof of the same to the Board, within a period of three months.**
7. The applicant shall seek prior permission from Board for transportation of Hazardous Waste.
8. The applicant should apply 45 days in advance for renewal of authorization before expiry of the authorization.
