GRANT OF AUTHORIZATION (RENEWAL) TO OCCUPIER OR OPERATOR FOR HANDLING HAZARDOUS WASTES

1. Number of authorization and date of issue 62 of 2016 dt 12-5-2016
2. **M/s Aman Paper Mills** is hereby granted an authorization (renewal) for storage of hazardous waste on the premises situated at **SICOP Industrial Estate Kathua**.
3. The authorization(Renewal) granted is for storage of hazardous waste generated from the manufacturing process of **Writing and Printing Papers etc. (14811.40 MTA)**.
4. The authorization(Renewal) shall be in force for a period of up to **31st August 2016**.
5. The authorization is subject to the conditions stated below and such other conditions as may be specified in the rules for the time being in force under the Environment (Protection) Act, 1986.



Terms and Condition of Authorization:

1. The authorization shall comply with the provisions of the Environment (Protection) Act, 1986, and the rules made there under.
2. The authorization or its renewal shall be produced for inspection at the request of an Officer authorized by the State Pollution Control Board.
3. Any unauthorized change in personnel equipment as working conditions as mentioned in the application by the person authorized shall constitute a breach of the authorization.
4. An application for the renewal of an authorization shall be made in form I before its expiry.

5. The applicant should maintain records of hazardous waste generated as per "Form-3".
6. Hazardous Chemicals be stored as per the Manufacture, Storage and Import of Hazardous Chemicals Rules ,1989
7. **The applicant should submit "Form-4" for filling returns as per Hazardous Waste (Management , Handling & Transboundary) rules 2008, by 30th June ,every year for the preceding period April to March.**
8. .The applicant shall make sure that the hazardous waste are packaged and labeled based on the composition in a manner suitable for safe handling and storage as per guidelines under rules.
9. **The applicant shall ensure total Chlorine free bleaching in the manufacturing process.**
10. The applicant shall conduct Mock Drills at least twice a year and submit the details of the same to the Board along with photographic proof.
11. The applicant should apply 60 days in advance for renewal of authorization before expiry of the authorization.
