**GRANT OF AUTHORIZATION (RENEWAL) TO OCCUPIER OR OPERATOR FOR
HANDLING HAZARDOUS WASTES**

1. Number of authorization and date of issue 07 of 2016 dt 2.4.2016
2. **M/s Komal Paper Mills (Unit II)** is hereby granted an authorization to operate a facility for storage of hazardous waste on the premises situated at **National Highway, Chak Gota, Kathua.**
3. The authorization granted is to operate a facility for storage of hazardous waste generated from the process of manufacturing of *White paper, MG paper, Media paper, Virgin paper, Mill and Craft board, Duplex board, Grey board etc. (20790 MTA).*
4. The authorization shall be in force for a period **up to 31/08/2016 in the first instance to be extended subject to successful installation of online monitoring system.**
5. The authorization is subject to the conditions stated below and such other conditions as may be specified in the rules for the time being in force under the Environment (Protection) Act, 1986.

Terms and Condition of Authorization

1. The authorization shall comply with the provisions of the Environment (Protection) Act, 1986, and the rules made there under.
2. The authorization or its renewal shall be produced for inspection at the request of an officer authorized by the State Pollution Control Board.
3. The person authorized shall not rent, lend, sell, transfer or otherwise transport the hazardous waste without obtaining prior permission of the Board.

4. An application for the renewal of an authorization shall be made in "Form-1" before its expiry.
5. The applicant should maintain records of hazardous waste generated at the facility, as per "Form-3".
6. Hazardous Chemicals be stored as per the Manufacture, Storage and Import of Hazardous Chemicals Rules, 1989.
7. The applicant shall submit "Form-4" for filing returns as per Hazardous Wastes (Management, Handling and Transboundary Movement) Rules 2008, by 30th June, every year for the preceding period April to March.
8. The applicant shall make sure that the hazardous wastes are packaged and labeled based on the composition in a manner suitable for safe handling & storage as per the guidelines under rule.
9. The applicant shall conduct Mock Drills at least twice a year and submit the details of the same to the Board along with photographic proof.
10. The applicant should apply 45 days in advance for renewal of authorization before expiry of the authorization.
