CONSENT ORDER

SPCB - 859 of 2016 dated 17-12-2016

Consent to **Operate (Renewal)** under section 25/26 of the Water (Prevention & Control of Pollution) Act, 1974, and under section 21 of the Air (Prevention & Control of Pollution) Act, 1981, as amended is granted in favour of

M/s Manohar Steels
Village Dianai Samba

for a period upto **November 2021** for a category of **Orange** as per revised classification of industrial sector, subject to the following terms and conditions in a time bound manner:

1. The consent granted by the Board is restricted to Prevention and Control of Pollution only and shall not be treated as substitute of permission required under other laws of the land.
2. The consent is granted valid for the manufacture of the products / by-products consented quantity as under with capital investment as per schedule II **Rs. 3.19 laes.** Any change / enhancement in production capacity , process , raw materials shall have be intimated to the board and unit holder has to apply fresh for the same

The emissions or discharge of environmental pollutants from the unit / establishment shall not exceed the relevant parameters and standards for the said industry, operation or process specified under respective schedules of the Environment (Protection) Rules, 1986 as amended from time to time.

3. Compliance under Water Act :

a. Standards for discharge of sewerage treatment

Sewage Treatment – The unit holder has to install a comprehensive treatment system as is warranted with reference to effluent quality and operate and maintain the same continuously so as to achieve the quality of treated effluent to the following standards before disposal :-

Parameters	Range	Conc. in mg/l except pH
pH	between	6-9
Suspended Solids	Not to exceed	100
BOD, 3 days, 27°C	Not to exceed	30

b. All the domestic waste water is disposed off through septic tank and soakage pit.

c. Water consumption

- i. The daily quantity of sewage effluent from the unit shall not exceed 0.1 KLD
- ii. The daily quantity of water consumption shall not exceed 0.4 KLD.

4. Compliance under Air Act:

a. The unit holder shall comply to **National Ambient Air Quality Standards** as per EP Act 1986 (refer rule 3(3B) .

5. Compliance under Noise Pollution (Regulation and Control) Rules 2000 as amended :

The unit holder shall take adequate measures for control of noise from its own sources within the premises so as to maintain ambient air quality standards in respect of noise to less than 75 db(A) during day time and 70 db(A) during night time. Daytime is reckoned in between 6am to 10pm and night time is 10pm to 6am.
