## AUTORIZATION IS GRANTED UNDER RULE 6(2) OF THE HAZARDOUS & OTHER WASTES (MANAGEMENT & TRANSBOUNDARY MOVEMENT) RULES 2016

1. Number of authorization and date of issue - 158 of 2017 dt 16-3-2017
2. Reference of application (No. and date) :- Nil
3. **Sh. Anil Gupta (M.D) of M/s Rajdhani Petrochemicals** is hereby granted an authorization based on the enclosed signed inspection report for generation, collection, reception, storage or any other use of hazardous or other wastes or both on the premises situated at **Ph I IGC Samba**.

### Details of Authorization



- (1). The authorization shall be valid for a period of **August 2017**.
- (2). The authorization is subject to the following general & specific conditions:

#### General Conditions Of Authorization:

1. The authorized person shall comply with the provisions of the Environment (Protection) Act, 1986, and the rules made there under.
2. The authorization or its renewal shall be produced for inspection at the request of an Officer authorized by the State Pollution Control Board.
3. The person authorized shall not rent, lend, sell transfer or otherwise transport the hazardous and other wastes except what is permitted through this authorization.
4. Any unauthorized change in personnel equipment as working conditions as mentioned in the application by the person authorized shall constitute a breach of his authorization.
5. The person authorized shall implement Emergency Response Procedure (ERP) for which this authorization is being granted considering all site specific possible scenarios such as spillages, leakages, fire etc. and their possible impacts and also carry out mock drill in this regard at regular interval of time.
6. The person authorized shall comply with the provisions outlines in the Central Pollution Control Board guidelines on "implementing Liabilities for Environmental Damages due to Handling and Disposal of Hazardous Waste and Penalty.
7. It is the duty of the authorized person to take prior permission of the State Pollution Control Board to close down the facility.
8. The imported hazardous and other wastes shall be fully insured for transit as well as for any accidental occurrence and its cleanup operation.
9. The record of consumption and fate of the imported hazardous and other wastes shall be maintained.
10. The hazardous and other waste which gets generated during recycling or reuse or recovery or pre-processing or utilization of imported hazardous or other wastes shall be treated and disposed of as per specific conditions of authorization.
11. The importer or exporter shall bear the cost of import or export and mitigation of damages, if any.
12. An application for the renewal of an authorization shall be made as laid down under these Rules.
13. The person authorized shall also comply with other conditions as per the Guidelines issued by the Ministry of Environment, Forest and Climate Change or Central Pollution Control Board from time to time.
14. **Annual return shall be filed by June, 30<sup>th</sup> for the period ensuring 31<sup>st</sup> March of the year.**

**Specific Condition:** The authorization shall be extended beyond August 2017 only if unit holder makes any captive scientific disposal facility or arrangement for sharing of authorized disposal facility is ensured, otherwise an action as warranted under the Hazardous and Other Wastes (Management and Transboundary Movement) Rules 2016, dt: 4-4-2016 shall be taken read with EP Act 1986.
