CONSENT ORDER

SPCB 750 of 2016 dated 26-10-2016

Consent to Establish (Fresh)

Under section 25/26 of the Water (Prevention & Control of Pollution) Act, 1974, and under section 21 of the Air (Prevention & Control of Pollution) Act, 1981, as amended is granted in favour of

M/s Cemtac Cements Pvt. Ltd.
Sulnar Saturnarg Khrew Pulwama.

for a period upto **One year from date of issue** and for a category of unit **Red** (as per classification of industrial sector) subject to the compliance and implementation of following terms and conditions in a time bound manner.

1. The consent granted by the Board is restricted to Prevention and Control of Pollution as per Water and Air Act only and shall not be treated as substitute of permission required under other laws of the land.
2. The consent is granted for the manufacturing of the following quantities of products / by-products consented as under with capital investment (as per schedule I) **Rs. 1194 lacs**. Further any change / enhancement in production capacity, process, raw materials shall have to be intimated to the board and unit holder has to apply fresh for the same.

3. **The emissions or discharge of environmental pollutants from the stone crusher shall not exceed the relevant parameters and standards prescribed under respective schedules of the Environment (Protection) Rules, 1986 as amended from time to time.**
4. The unit holder shall comply to the **Noise Pollution (Regulation and Control) Rules 2000 as amended** take adequate measures for control of noise from its own sources within the premises so as to maintain ambient air quality standards in respect of noise to less than 75 db(A) during day time and 70 db(A) during night time. Daytime is reckoned in between 6am to 10pm and night time is 10pm to 6am.
5. The unit holder shall comply to the water (Prevention and control of pollution) Act 1974 and comply to the following parameters
 - a. Daily quantity of water consumption the unit shall not exceed 75 KLD.
 - b. The unit holder shall take adequate safe guards for the treatment of sewerage water by way of providing septic / soakage pit and its discharge shall confirm to the following standards

BOD (3 DAYS 27 ⁰ c)	30
Total Suspended Solid	100

6. Standards for discharge of Air emissions:

a. The entrepreneur shall comply to National Ambient Air Quality Standards as per EP Act 1986 (refer rule 3(3B) .

b. Emission Standards from stack:

SO ₂	200 mg / Nm ³
NO ₂	500 mg / Nm ³

7. The unit holder shall install a comprehensive air pollution control system at the time of operation of unit so as to achieve the quality of emissions within the limits prescribed under Environment Protection Act 1986 (EP Act).



9. The unit shall not discharge any fugitive emissions from the unit.
10. The unit holder shall comply with any other condition laid down or directions issued in due course by the J&K State Pollution Control Board under the provisions of Air (Prevention and Control of Pollution) Act, 1981.
11. The unit holder shall abide by the directions of the Board which will be issued from time to time. Any infringement/violation or transgression of the statutory enactments of pollution control acts by the Unit, shall be sufficient cause to prosecute the violator in conformity with relevant section of Air, Water Acts and Environment Protection Act in force.
12. The unit shall be under surveillance monitoring of J & K State Pollution Control Board.

13. The unit holder shall not operate the unit unless Board issue consent to operate fresh.
14. The unit holder shall raise green belt of suitable plant species within the premises of unit.
15. In case of violation of above mentioned conditions or any public complaint the consent shall be withdrawn and unit holder shall shift the unit to another suitable site at his own risk and responsibility.
16. That the unit holder shall comply with the condition of the Environmental Clearance got from the Ministry of Environment and Forests, New Delhi vide no. 19-05-2016 submitted by the unit holder for increase of capacity from 200 TPD to 500 TPD in the first Phase before seeking Consent to Operate for additional 300 TPD. The consent to establish for additional capacity is issued being the unit come up at the same place where it already in operation for 200 TPD and after the clearance from Ministry of Environment and Forests, New Delhi under EIA notification.
17. That unit holder shall install all the requisite Air Pollution Control Devices of latest art of technology to comply with the latest standards of emissions as issued under the EP Act and unit holder shall install on-line monitoring system in additional capacity before seeking consent to operate from the Board. The above conditions shall be enforced inter-alia under the provision of the Water (Prevention and Control of Pollution) Act 1974, Air (Prevention and Control of Pollution) Act 1981 and Environment (Protection) Act 1986.
18. The above conditions shall be enforced inter-alia under the provision of the Water (Prevention and Control of Pollution) Act 1974, Air (Prevention and Control of Pollution) Act 1981 and Environment (Protection) Act 1986.

* This consent is issued purely from environmental angle and the Board shall not be responsible for any claim, counter claim, ownership, partnership etc. of the unit.
