CONSENT ORDER

SPCB 763 of 2016 dated 27-10-2016

Consent to Operate (Renewal)

Under section 25/26 of the Water (Prevention & Control of Pollution) Act,1974, and under section 21 of the Air (Prevention & Control of Pollution) Act,1981, as amended is granted in favour of

for a period upto **December 2020** and for a category of unit **Orange** (as per classification of industrial sector) subject to the compliance and implementation of following terms and conditions in a time bound manner :-

1. The consent granted by the Board is restricted to Prevention and Control of Pollution as per Water and Air Act only and shall not be treated as substitute of permission required under other laws of the land.
2. The consent is granted for the manufacturing of the following quantities of products / by-products consented as under with capital investment (as per schedule I) **Rs. 9.85 lacs.** Further any change / enhancement in production capacity , process , raw materials shall have be intimated to the board and unit holder has to apply fresh for the same.

3. **The emissions or discharge of environmental pollutants from the unit / establishment shall not exceed the relevant parameters and standards for the said industry, operation or process specified under respective schedules of the Environment (Protection) Rules , 1986 as amended from time to time.**
4. The unit holder shall comply to the of National Ambient Air Quality Standards as per EP Act 1986 (refer rule 3(3B) .
5. The unit holder shall comply to the **Noise Pollution (Regulation and Control) Rules 2000 as amended** take adequate measures for control of noise from its own sources within the premises so as to maintain ambient air quality standards in respect of noise to less than 75 db(A) during day time and 70 db(A) during night time. Daytime is reckoned in between 6am to 10pm and night time is 10pm to 6am.
6. The unit holder shall comply to the water (Prevention and control of pollution) Act 1974 and comply to the following parameters

- a. Daily quantity of water consumption the unit shall not exceed 0.2 KLD.
- b. The unit holder shall take adequate safe guards for the treatment of sewerage water by way of providing septic / soakage pit and its discharge shall confirm to the following standards

pH	6 - 9
BOD (3 DAYS 27 ⁰ c)	30
Total Suspended Solid	100

7. The unit holder has to operate and maintain a comprehensive water / Air pollution control system so as to achieve the quality of effluents / emissions within the limits prescribed under Environment Protection Act 1986 (EP Act).

All the domestic sewage is treated through septic tank and soakage pit.

8. Conditions under Air Act :

(I)The applicant has to operate stack(s) of the following specifications :

- (II) The applicant has to operate and maintain a comprehensive air pollution control system consisting of control equipment as detailed below to control the emissions continuously so as to achieve the level of pollutants.

9. The unit shall not discharge any fugitive emissions from the unit.
10. The unit holder shall comply with any other condition laid down or directions issued in due course by the J&K State Pollution Control Board under the provisions of Air (Prevention and Control of Pollution) Act, 1981.
11. The unit holder shall abide by the directions of the Board which will be issued from time to time. Any infringement/violation or transgression of the statutory enactments of pollution control acts by the Unit, shall be sufficient cause to prosecute the violator in conformity with relevant section of Air, Water Acts and Environment Protection Act in force.
12. The stone crusher shall be under surveillance monitoring of J & K State Pollution Control Board.
13. The entrepreneur shall install the latest state of art technology Air pollution control devices for control of volatile organics emission well within permissible limit and ensure that emission shall not be vented out untreated so as to cause any adverse environmental impact to the adjoining areas.
14. **The entrepreneur shall submit self monitoring report from the J&K SPCB approved laboratory or Board's own laboratory to check the quality of emissions standards prescribed under environment protection act 1986 as per schedule given below.**

15. The entrepreneur shall manufacture only the products as per the license issued by Agriculture Department.
16. In case of violation of above mentioned conditions or any public complaint the consent shall be withdrawn and unit holder shall shift the unit to another suitable site at his own risk and responsibility.
17. The above conditions shall be enforced inter-alia under the provision of the Water (Prevention and Control of Pollution) Act 1974, Air (Prevention and Control of Pollution) Act 1981 and Environment (Protection) Act 1986.

** This consent is issued purely from environmental angle and the Board shall not be responsible for any claim, counter claim, ownership, partnership etc. of the unit.*
