Subject:- Extension of validity of Consent to Operate (Fresh) issued vide order no. 1196 of 2017 dated 06-03-2017 in favour of M/s H.K. Cement Industries Pvt. Ltd., Zantrag Khrew, Pulwama

The validity of Consent to Operate (Fresh) of M/s H.K., Cement Industries Pvt. Ltd., Zantrag Khrew, Pulwama issued vide consent order no. 1196 of 2017 dated 06-03-2017 under endorsement no. SPCB/T/c/Pul/06/3471-74 dated 06-03-2017 is hereby extended for a period of another six months i.e. upto 31st March-2018. The terms and conditions of the previous consent order shall remain same. In addition to conditions spelled out in consent order of No. 1196 of 2017 dated 06-03-2017, the unit holder shall follow the below noted conditions as well:-

- 1- This extension is subject to the clearance from National Board for Wildlife, Government of India, New Delhi.
- 2- Investment made by the unit holder in establishing the unit and operation thereof, in anticipation of National Wildlife Board clearance shall be squarely at the risk and responsibility of the entrepreneur / unit holder and the J&K State Pollution Control Board shall in no way be responsible for any loss incurred by the unit, in case of refusal of clearance by the National Wildlife Board.
- 3- Unit holder shall indemnify the State of Jammu and Kashmir / J&K State Pollution Control Board for any loss to environment / wildlife, caused by operation of the factory.
