CONSENT ORDER

Consent to **Operate (Renewal)** under section 25/26 of the Water (Prevention & Control of Pollution) Act, 1974, and under section 21 of the Air (Prevention & Control of Pollution) Act, 1981, as amended is granted in favour of

for a period up to **May 2018** for a category of **Orange** as per revised classification of industrial sector, subject to the following terms and conditions in a time bound manner:

1. The consent granted by the Board is restricted to Prevention and Control of Pollution only and shall not be treated as substitute of permission required under other laws of the land.
2. The consent is granted valid for the manufacture of the products / by-products consented quantity as under with capital investment as per schedule II **Rs. 96.90 lac. (As per Schedule-II)**. Any change / enhancement in production capacity, process, raw materials shall have be intimated to the board and unit holder has to apply fresh for the same:

The emissions or discharge of environmental pollutants from the unit / establishment shall not exceed the relevant parameters and standards for the said industry, operation or process specified under respective schedules of the Environment (Protection) Rules, 1986 as amended from time to time.

3. Compliance under Water Act:

a. Standard of discharge for Trade Effluent:

Treatment – The unit holder has to install, operate and maintain a comprehensive effluent treatment system consisting of Primary / Secondary and / or Tertiary treatment so as to achieve the quality of treated effluent to the following standards:-

b. Standards for discharge of sewerage treatment:

Sewage Treatment – The unit holder has to install a comprehensive treatment system as is warranted with reference to effluent quality and operate and maintain the same continuously so as to achieve the quality of treated effluent to the following standards before disposal :-

pH	between	6-9
Suspended Solids	Not to exceed	100 mg/l
BOD, 3 days, 27°C	Not to exceed	30 mg/l
