Whereas, no industrial unit can be set up or run, without the prior consent of the Pollution Control Board, as warranted under Section 25/26 and Section 21 of the Water (Prevention and Control of Pollution) Act 1974 and Air (Prevention and Control of Pollution) Act, 1981 respectively.

Whereas, last consent granted to the **M/s SHIRAZ Stone Crusher, Samurbugh, Lasjan-Budgam** was valid upto, **March, 2017** and thereafter the unit holder has failed to obtain periodical renewals of the consent from the Pollution Control Board besides failing in installing requisite pollution control devices/ pollution control measures.

Whereas, the unit holder was accordingly served with repeated notices, particularly notice dated **15-02-2019**, calling upon him there under to show reasons as to why legal action including closure of his unit be not taken.


Whereas, the unit holder has failed to show any tenable response to the notice, besides failing to take measures to meet the requirements of laws governing environmental protection


Whereas, the unit in question cannot be allowed to run un-authorizedly with above status to the detriment of human health and environment.

Now therefore in exercise of powers vested in the J & K State Pollution Control Board under Section 31 (A) of the Air (Prevention and Control of Pollution) Act, 1981, immediate closure of **M/s SHIRAZ Stone Crusher, Samurbugh, Lasjan- Budgam** is hereby ordered and in this behalf the:

- i). Deputy Commissioner/ District Magistrate, **Budgam** is directed to close **M/s SHIRAZ Stone Crusher, Samurbugh, Lasjan- Budgam**, immediately.
- ii). Chief Engineer, Electric & Maintenance (PDD) **Kashmir** is directed to snap the electric supply to the above said unit, immediately.
- iii). Director Industries & Commerce, **Kashmir** is directed to deregister the unit.
- iv). Prop. **M/s SHIRAZ Stone Crusher, Samurbugh, Lasjan- Budgam** is directed to cease the operation of the unit forthwith.
