ORDER : 00 SPCB of 2019
Dated : 01-04-2019

Whereas, no commercial activity which may result in generation of waste water can be taken in hand for installation or operation, as envisaged under **Section-25/26** of the **Water (Prevention and Control of Pollution) Act, 1974**.

Whereas, Hotel industry is one of such activities which generates lot of sewage waste water and each hotel is required to have the treatment facility in place and functional in the shape of STP for category 'A' Hotels (with 20 or more rooms) and soakage pit and septic tank for category 'B' Hotels (with less than 20 rooms).

Whereas, having above said treatment facilities in place becomes all more imperative if hotel is located near a water body or ecologically sensitive zone.

Whereas, M/s Hotel Leeward Nehru Park, Srinagar has been setup and put up in operation in violation of above said norms of Law in immediate vicinity of the Dal Lake thereby affecting the water quality of the lake adversely.

Whereas, all the commercial establishments/Hotels were repeatedly called upon to adhere by the requirements of law by having proper sewage treatment facility in the shape of operational STP and obtaining consent of the Board.

Whereas, M/s Hotel Leeward Nehru Park, Srinagar failed to show any tenable response besides failing to adhere to the requirements of law thereby breaching legal obligations with impunity

Whereas, notice was accordingly served upon the concerned hotelier vide notice dated **13-03-2019** to which the hotelier has failed to respond.

Now, therefore, in exercise of powers vested in the Chairman, Jammu and Kashmir, State Pollution Control Board under **Section-33A** of **Water (Prevention and Control of Pollution) Act, 1974**, immediate closure of M/s Hotel Leeward Nehru Park, Srinagar is hereby ordered and in this behalf, the:-

- i. Deputy Commissioner/ District Magistrate Srinagar is directed to immediately close down the hotel M/s Hotel Leeward Nehru Park, Srinagar.
- ii. Director, Tourism Kashmir with the direction to immediately revoke the registration of hotel in question.
- iii. Chief Engineer, Electric & Maintenance (PDD), Kashmir with the direction to snap electric supply to the hotel immediately.
- iv. Nazir Ahmad & Ors. Prop. M/s Hotel Leeward Nehru Park, Srinagar is directed to cease the operation of the hotel forthwith.
