**ORDER : 25 SPCB of 2019**  
**Dated - 15-05-2019**

Whereas, the Proprietor of **M/s N.V. Enterprises, Sh. Vijay Sharma** has setup and put up in operation, a polythene manufacturing unit at I/E Gangyal, Jammu illegally and in blatant violation of Environmental Laws especially **Section 25 and 21 of Water (Prevention and Control of Pollution) Act 1974 and Air (Prevention and Control of Pollution) Act 1981, respectively** where under consent of the Board for such activity is mandatory.

Whereas, the polythene carry bags and allied products of less than 50 microns thickness are banned in the State of Jammu and Kashmir in terms of **SRO-45 dt. 03-02-2017**.

Whereas, on the basis of field inputs, it was established that the unit holder is engaged in illegal and unauthorised activity of polythene manufacturing and on being cautioned, the unit holder undertook to desist from the activity.


Whereas, the unit was kept in constant surveillance and on receiving inputs about continued illegal & unauthorised manufacturing of banned polythene carry bags (less than 50 microns thickness), the team was deputed and huge quantity of banned polythene carry bags (**12655 kg**) was seized from the premises of the unit on **05-02-2019** and confiscation proceedings started under rules.


Whereas, with a view to incapacitate the unit holder from repeating the offence of illegal polythene manufacturing that too in violation of **Section 25 and 21 of Water (Prevention and Control of Pollution) Act 1974 and Air (Prevention and Control of Pollution) Act 1981, respectively**, immediate closure and blacklisting of the unit is warranted.

Now, therefore, in exercise of powers vested in the Chairman, Jammu and Kashmir, State Pollution Control Board under **Section-33A of Water (Prevention and Control of Pollution) Act 1974 and Section 31A of Air (Prevention and Control of Pollution) Act 1981, read with Section 5 of Environment (Protection) Act 1986**, blacklisting and immediate closure of **M/s N.V. Enterprises, I/E Gangyal, Jammu** is hereby ordered and in this behalf, the:-

- Deputy Commissioner Jammu is directed to immediately close down the unit and seal the premises.
- Director, Industries and Commerce, Jammu is directed to blacklist the owner **Sh. Vijay Sharma** of **M/s N.V. Enterprises, I/E Gangyal, Jammu** for further registration of any unit and cancel the registration of this unit if the registration is still in force.
- Chief Engineer, Electric & Maintenance (PDD), Jammu is directed to snap electric supply to the unit forthwith.
