ORDER NO. : 32 SPCB of 2019

Whereas, closure of M/s **72 BPM Hospital** was ordered by the Board vide Order No. **108 of SPCB 2018 dated 18-12-2018** for the failure of the management to obtain consent of the Board and to meet the requirements of Bio Medical Waste (Management and Handling) Rules 2016 including obtaining of upto date authorization from the Board.


Whereas, the management of the Health Care Facility represented against the closure order vide representation dated 22-12-2-18 stating that in surgery cases post operative care has become difficult, in view of the closure of the Health Care Facility ordered by the Board, besides stating that requirements of laws governing environmental protection shall be met which include installation of STP.

Whereas, order was accordingly kept in abeyance vide order No. 110 SPCB of 2018 dated 26-12-2018 and corrigendum dated 26-12-2018 to facilitate post operative care of surgery cases and installation of STP.

Whereas, a team was constituted by the Board to assess the situation at the site and report about the ground position in detail.

Whereas, the report of the committee was received, informing that no patient is currently admitted in the Health Care Facility and owner has failed to obtain authorization since May, 2018, besides failing to take any concrete step to install the STP.

Now therefore in view of the above facts, coupled with the complaints received against the Health Care Facility, Order No. 110 SPCB of 2018 dated 26-12-2018 and corrigendum thereof issued vide No. SPCB/LS/72/2018/1170-75 dated 26-12-2018 is hereby withdrawn with immediate effect for enforcement of Closure Order No. 108 SPCB of 2018 dated 18-12-2018.
