Whereas, no industrial unit can be installed or run, without up to date consent of the Pollution Control Board, as prescribed under Section 25/26 and Section 21 of the Water (Prevention and Control of Pollution) Act 1974 and Air (Prevention and Control of Pollution) Act, 1981 respectively.

Whereas, M/s **Tarmac Road and Roof Builders, Birwan Nalalh, Udhampur** is operational in flagrant violation of above said requirements of laws governing environmental protection.

Whereas, apart from being in unauthorized operation, Hotmix Plant indicated above is also being run bereft of adequate pollution control devices/ pollution control measures to the detriment of human health and environment.

Whereas, the unit holder was accordingly served with repeated notices, calling upon him there under to show reasons as to why legal action including closure of their unit be not taken.


Whereas, the unit holder has failed to show any response to the notices, besides failing to take measures to meet the requirements of laws governing environmental protection.


Whereas, the unit cannot be allowed to run un-authorized with above status and to the detriment of human health and environment.

Now therefore in exercise of powers vested in the J & K State Pollution Control Board under Section 31(A) of the Air (Prevention and Control of Pollution) Act, 1981, immediate closure of M/s **Tarmac Road and Roof Builders, Birwan Nalalh, Udhampur** is hereby ordered and in this behalf the:-

- i. Deputy Commissioner/ District Magistrate, **Udhampur** is directed to close down M/s **Tarmac Road and Roof Builders, Birwan Nalalh, Udhampur** immediately.
- ii. Chief Engineer Electric & Maintenance (PDD) **Canal Road Jammu** is directed to snap electric supply to above said unit immediately.
- iii. Director Industries & Commerce **Jammu** is directed to suspend the registration of the above said unit.
- iv. Prop. M/s **Tarmac Road and Roof Builders, Birwan Nalalh, Udhampur** is directed to cease the operation of the unit forthwith.
